ORDER:

Through the reference 1st read above, the Government after careful examination of the matter, hereby accord administrative sanction for amount **Rs. 8055.57 Lakhs (Rupees Eighty Crores Fifty Five Lakhs and Fifty Seven Thousand only)** for taking up the works pertaining to Sri Sammakka Saralamma Medaram Jathara 2018, out of which **Rs. 232.11 Lakhs (Rupees Two Hundred Thirty Two Lakhs and Eleven Thousand only)** sanctioned to District Panchayat Officer, Jayashankar Bhupalpally.



- The District Panchayat Officer, Jayashankar Bhupalpally is directed to submit the activity wise Utilization Certificate (U.C.) to this office.
