**ORDER:**

Through the reference 1<sup>st</sup> read above, the Government after careful examination of the matter, hereby accord administrative sanction for amount **Rs. 8055.57 Lakhs (Rupees Eighty Crores Fifty Five Lakhs and Fifty Seven Thousand only)** for taking up the works pertaining to Sri Sammakka Saralamma Medaram Jathara 2018, out of which **Rs. 260.00 Lakhs (Rupees Two Hundred and Sixty Lakhs only)** sanctioned to Executive Officer, Endowment Department, Jayashankar Bhupalpally.

Through the reference 2<sup>nd</sup> read above, the Executive Officer, Endowment Department, Jayashankar Bhupalpally has submitted for the proposals for sanction of (11) works with an estimated cost of **Rs. 260.00 Lakhs (Rupees Two Hundred and Sixty Lakhs only)** the details of works as below:

Therefore, administrative sanction is hereby accorded for the above (11) works with an estimated cost of **Rs. 260.00 Lakhs (Rupees Two Hundred and Sixty Lakhs only)** for taking up works in ensuring Sri Sammakka Saralamma Medaram Jathara 2018 funds under Tribal Welfare Department funds under the Head of the Account 4225-02-800-25-(05)-530-531 and entrusted to Executive Officer, Endowment Department, Jayashankar Bhupalpally District for execution.

**The Executive Agency is directed to prepare the detailed estimates and take the technical sanction approval from the competent authority before grounding the work, a copy of the estimates may also be sent to the Chief Planning Officer for making payments.**

The Concerned Executive agencies are requested to execute the above sanctioned **(11) works** by following the Departmental norms and submit the MB record, Photographs and work completion report in **(17) column format** to the Chief Planning Office, Jayashankar Bhupalpally for release of funds.

**The following terms and conditions should be followed by the Executing Agency while executing the works.**

- The works shall be commenced duly calling for short tenders and complete the works on or before 05.01.2018.
- The works should be executed strictly as per technical sanction and completed within maximum period of (03) months without creating any spill over.
- There should not be any deviation to the nomenclature of works of the administrative sanction accorded.
- If the works are not completed within the stipulated time, suitable action will be initiated against the implementing agency.
- The Executing Agency should confirm that the works now sanctioned now have not been sanctioned earlier under any Govt. scheme/programme before grounding the works.
- Tribal Welfare Department guidelines and Departmental norms should be followed scrupulously.
- The works should be completed within the sanctioned amount only and no further funds will be allotted for spillover works.
- The Executing Agency should get in advance a firm commitment about the operation, upkeep and maintenance of the proposed asset from the user agency concerned before the execution of the works sanctioned.
- The Executing Agency should maintain Assets creation register for sanctioned and completed works of Tribal Welfare Department.
- The Executing Agency should furnish the photos of the site before starting, in progress and after completion of each work along with the completion report to Chief Planning Officer, Jayashankar Bhupalpally.
- Monthly progress report should be furnished to the Chief Planning Officer, Jayashankar Bhupalpally by 5<sup>th</sup> of every month.
- The Executing Agency shall personally holds the responsibility to get it confirmed from the concerned authorities before grounding the works that the location of the works site is free from litigation.
- **Quality Control Certificate may please be furnished along with MB for payment.**
- **After Completion of the work the asset may be handover to the concerned user Agency.**


