ORDER:

- The works shall be commenced duly calling for short tenders and complete the works on or before 05.01.2018.

- The Executing Agency should furnish the photos in progress and after completion of each work along with the completion report to Chief Planning Officer, Jayashankar Bhupalpally.
- The Superintendent of Police, Jayashankar Bhupalpally to produce the all receipts & bills to Chief Planning Office, Jayashankar Bhupalpally.


